EVALUATION PROCESS:

Evaluation will be based on the information provided and meeting a selection board, date to be determined.

MANDATORY REQUIREMENTS: 9 Yrs TIS, 2 Yrs TIG as E-6, NCOA. Selected member must meet requirements as directed by the AFECD and AFI 36-2113. Requirements are, but not limited to the following: Must have an overall EPR rating of 5 and/or have "Exceeded some" expectations and/or "Exceeded Most" expectations on the last three performance reports. No convictions by a civilian court except for minor traffic violations. Fitness score of at least 80 or above on last two fitness tests, or 90 or above on most recent fitness test, no failure of any portion within the last 12 months or exemptions from any component (except deployment and/or pregnancy). Must have completed USAF Senior NCO Academy, or must immediately enroll in correspondence upon selection and complete within 12 months. Must possess a CCAF degree or must complete CCAF degree within 18 months of completing First Sergeant Academy.
