FAILURE to provide this documentation will result in the application being returned without action
  - c. Application must be signed
2. Current & complete Report on Individual Personnel (RIP) printout from virtual MPF
3. Most recent copy of current and passing fitness assessment
4. Military Biography
5. Three most recent OPRs
6. Two most current AGR orders from AROWS (Air National Guard Reserve Order Writing System) or your letter from the ACB (AGR Continuation Board) to show you are in career status
7. If member is not career status, member must provide a letter from their Wing/GSU commander authorizing them to bring their resource
8. Letter from Force Support Squadron (FSS) certifying promotion eligibility
